A. Mayor-Erik Premont: I have recently been made aware of a citizen shooting firearms at stray dogs within the city limits. One resident has already called the Sherriff's office. This person called Mark Owens, but he is just with the P&Z and has no authority. He suggested the call to the Sherriff. The people who are doing the shooting does not have enough property to be using the firearms out in an open space. They don't have a back stock and it is a tiny lot.

A letter will be sent to their address warning them of the nuisance order.

Liberty Sanitation has been putting out receptacles and picking up trash in the city limits. There is an ordinance against this. There is exclusivity with County Trash within the city limits where this is concerned.

(Pat) I have sent an email to TML and asked them what we can do about it. They have two trucks and I am wondering if maybe they have changed hands. We have sent them a letter before and they pulled out.

(Claude) I know that with our agreement that we have signed with County Trash they have exclusivity.

(Erik) The other I have is about the chairs that Joe Passanisi wants them. Pat will text him and he should pick them up on Thursday.

B. Mayor Pro Tem-Claude Lewis, Jr.: My will be on Number 8. I have a news letter ready to send out. It will be a trifold. It is not that a big deal and the price will fall under the office supply budget.

D. City Secretary-Pat Patterson (activities and information): I got Barbara Pearson's First-Class letter as well as Certified Mail sent out on the 18th.

7. Consider and take action regarding the acquisition of accessories to be used to clear out ditches and trimming of trees in the city limits.

This one we can buy and it won't be that much. Three point-3 positions; will go from 90% degree to 110% degree for \$3000.

8. Consider and take action regarding the following City of Ravenna public works projects: street Maintenance, road work, and culverts; solar streetlights; tree trimming and mowing.

Discuss travel RVs and citizens residing in them. Repairs to the street and stop sign on the corner of Cedar and Main. Pipes and foundational rebar in back of City Hall building need cleanup.

(Red Bud washout)

No one was at the Maple St house RV.

(400 S. Main) Send the people with the guns a letter. Their sewage is going straight into the drainage ditch. We don't have an Interlocal agreement with the county.

Contact TCEQ about sewage. This is also 8 or 9 dogs at this address as well as the shooting. The Ordinance for dogs is 17A. The Ordinance 29 is nuisance for rubbish and unsanitary manner.

On the backside of the house is an RV with hoses hooked up to it.

(Sharon Roberts 311 S. Main St.) There is an RV next to the brick home to see if there is anyone living in it.
